On 5 December 2022, 3-year convertible bonds in the aggregate principal amount of HK\$52,000,000 with 0% interest per annum (the "Convertible Bonds") were issued by the Company pursuant to the equity transfer agreement dated 19 August 2022. On 12 June 2024, the parties entered into the second supplemental agreement (the "Second Supplemental Agreement") to amend the said equity transfer agreement, pursuant to which the Convertible Bonds has automatically cancelled on 1 December 2025 as a subsidiary of the Company cannot obtain the Gas Business License on or before 30 November 2025.
